ALTERNATIVE DISPUTE RESOLUTION AGREEMENT

1. How This Agreement Applies.

This Agreement is governed by the Federal Arbitration Act, 9 U.S.C. § 1 et seq. Except as it otherwise provides, this Agreement applies to any past, present, or future dispute arising out of or in any way related to Contractor's ("Contractor's") Contractor Service Agreement with Fidelity National Home Warranty Company, including any its affiliates, successors, subsidiaries, assigns or parent companies (collectively, "FNHW"). This Agreement equally covers any past, present, or future dispute arising out or in any way related to Contractor's relationship with, provision of services to, or provision of services on behalf of FNHW.

This Agreement survives the end of the Contractor Service Agreement. Except as it otherwise provides, this Agreement is intended to apply to the resolution of disputes that otherwise would be resolved in a court of law or before a forum other than arbitration. This Agreement requires all such disputes to be resolved only by an arbitrator through final and binding arbitration and not by way of court or jury trial. Except as this Agreement otherwise provides, such disputes include without limitation disputes arising out of or relating to interpretation or application of this Agreement, including the formation, scope, application, enforceability, revocability or validity of the Agreement or any portion of the Agreement. Nothing contained in this Agreement shall be construed to prevent or excuse Contractor (individually or in concert with others) or FNHW from utilizing FNHW's existing internal procedures for resolution of complaints, and this Agreement is not intended to be a substitute for the utilization of such procedures.

Except where this Agreement otherwise provides, this Agreement also applies, without limitation, to disputes with any entity or individual arising out of or related to Contractor's contracting with FNHW, background checks, privacy, Contractor's provision of Services or the termination of the relationship (including without limitation post-relationship defamation or retaliation), contracts, trade secrets, unfair competition, compensation, and claims arising from alleged employment including claims regarding meal breaks and rest periods, classification, minimum wage, seating, expense reimbursement, overtime, discrimination, harassment, retaliation and claims arising under the Fair Credit Reporting Act, Defend Trade Secrets Act, Civil Rights Act of 1964, 42 U.S.C. § 1981, Rehabilitation Act, Civil Rights Acts of 1866 and 1871, Civil Rights Act of 1991, 8 U.S.C. § 1324b (unfair immigration related practices), Pregnancy Discrimination Act, Equal Pay Act, Americans With Disabilities Act, Age Discrimination in Employment Act, Family Medical Leave Act, the California Fair Employment and Housing Act, the California Labor Code, Fair Labor Standards Act, Employee Retirement Income Security Act (except for claims for employee benefits under any benefit plan sponsored by FNHW and covered by the Employee Retirement Income Security Act of 1974 or funded by insurance), Affordable Care Act, Genetic Information Non-Discrimination Act, Uniformed Services Employment and Reemployment Rights Act, Worker Adjustment and Retraining Notification Act, Older Workers Benefits Protection Act of 1990, Occupational Safety and Health Act, Consolidated Omnibus Budget Reconciliation Act of 1985, False Claims Act, and state or local statutes or regulations, if any, addressing the same or similar subject matters, and all other federal, state and local legal, statutory and common law claims arising out of or relating to Contractor's relationship with FNHW, whether such disputes potentially arise under the Contractor Service Agreement, contract law, tort law, statute, or otherwise.

This Agreement also does not apply to claims for workers' compensation benefits, state disability insurance or unemployment insurance benefits.
